**WHEREAS:**

The Preamble of the ASCSU Constitution states:

“ . . . This commitment will be fulfilled by a continual re-examination of organizational structures for inclusiveness, by creating programs and services that provide education and support, and by speaking out and fighting against acts of discrimination on campus and within the Fort Collins community.” and,

**WHEREAS:**

The lack of gender inclusive restroom facilities on campus affects students as a passive form of discrimination; and,

**WHEREAS:**

The Campus Climate Subcommittee has submitted a proposal to be added to the Master Plan which includes provisions to include gender inclusive facilities in building protocol standards for the university, as well as increased accessibility through Campus Maps of all such facilities on campus; and,

**WHEREAS:**

It is the responsibility of the ASCSU Senate to act as the voice and immediate acting power of the student body to promote the ideals and actualization of student needs; so,

**THEREFORE BE IT HEREBY RESOLVED:**

That the 44<sup>th</sup> Senate hereby endorses the ideas outlined in the Campus Climate Subcommittee proposal. This endorsement includes a strong urge for the acceptance of this proposal into the updated Master Plan for the university; and,

**THEREFORE BE IT HEREBY FURTHER RESOLVED:**

That it is requested that the CSU administration and Facilities Management consider budgeting for some imminent renovations, especially signage, to help forward the goals of creating an inclusive institution for FY16; and,

**THEREFORE BE IT HEREBY FURTHER RESOLVED:**
