**WHEREAS:**

Article 1, Section 101 states:

“This Constitution shall be supplemented by the bylaws of the ASCSU Executive, Legislative, and Judicial branches, and the additional constitutions and bylaws of other ASCSU recognized clubs and organizations. Each of these shall have the authority to adopt such bylaws. None of these documents shall supersede the provisions of this Constitution.” and,

**WHEREAS:**

Currently the Executive branch of ASCSU does not have any updated bylaws; and,

**WHEREAS:**

Such bylaws could describe the retention of certain positions within the Executive Branch such as the Director of Health, the Director of Student Services, etc; and,

**WHEREAS:**

The current system does not have a clear set of rules regarding the removal of an official in the Executive Branch; so,

**THEREFORE BE IT HEREBY RESOLVED:**

That the 44<sup>th</sup> Senate requests that the Executive Branch write governing bylaws regarding the rules and regulations pertaining to Executive members; and,

**THEREFORE BE IT HEREBY FURTHER RESOLVED:**

That it is requested that these bylaws include the creation and retention of several of the current Executive positions not mentioned specifically in the ASCSU Constitution including, but not limited to, the Director of Health, Director of Outreach, Director of University Affairs, Director of Student Services, Director of Environmental Affairs; and,

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That it is requested that the Executive Branch retain the right to add or remove department positions not mentioned above at their discretion with the consent of the Senate; and,

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That it is requested that these bylaws mention a need for cabinet meetings to take place at the discretion of the Chief of Staff; and,

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That it is requested that a comprehensive and concise removal process of members of the branch be put in these bylaws; and,

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That these bylaws not conflict with the ASCSU Constitution in accordance with Article 1, Section 101; and,

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That a copy of this legislation be forwarded to Samantha Guinn, President of ASCSU; Lance C. Li Puma, Vice President of ASCSU; Hugo Pasillas, Chief of Staff; Lauren Wester; Deputy Chief of Staff
