  - As a supreme court we have been working on various trainings and workshops to help our old and new members alike. This week during our Supreme Court Meeting we had in Dr. Craig Chesson, the Director of Conflict Resolution and Student Conduct Services, as well as the Assistant Dean of Students. He taught and gave a workshop on Pre-Admit hearings and Substance Abuse ticket appeals. As a court we have been sitting on pre-admit hearings for years, and they make up a significant amount of court individuals time. It is important to have training done regularly in order to have a strong sense of what the CSU community expects and would like to have apart of their campus before going into these hearings. Substance Abuse Ticket Appeals is new to the conduct process and is new to the Supreme Court as well. These are for students who have gotten substance abuse tickets on campus and would like to have an appeal regarding it. So far there have been quite a few of these appeals held and only a few of our members were trained to sit on them. It will be good for the rest of the court to now be able to be apart of these hearings and share the burden of these cases.
  - In AUHB we have heard three cases to date. The third case will be discussed and deliberated on next Thursday the 25<sup>th</sup>. I am very happy with how well the board is working together, with the new members it is important to make everyone feel welcome and like their opinions matter in this context. Sometimes having fresh eyes on a case is the best thing possible. I am looking forward to working with this group more as the year continues.
