ABSTRACT: A Supplemental Bill to reallocate funds in order to fund line items that have presented themselves after the budgeting process was finished.

---

**WHEREAS**

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University permits the President to reallocate budgeted and unbudgeted funds as necessary as stated:

*“During the course of the fiscal year the President may reallocate budgeted and unbudgeted funds, as s/he deems necessary. If the President decides to move funds between the departments that exist within ASCSU accounts, the change must be submitted to the Senate in the form of a Supplemental Funding Bill” ; and,*

**WHEREAS**

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University requires the President to seek approval from the Senate through a Supplemental Funding Bill if the funds being reallocated are between accounts; and,

**WHEREAS**

The Department of Governmental Affairs would like to continue their subscription of the Colorado Statesman in order to keep themselves informed of state/local politics and have in the office to help keep other members informed. The subscription has expired and costs \$179.00; and,

WHEREAS

The Department of Environmental Affairs has been putting on many events to help create awareness on crucial issues regarding environmentalism and sustainability. Many of these events and calls to action involve different means to draw students in that might not have express interest beforehand, such as providing food or apparel. They have expressed that in order to keep them on the trajectory of success that they have been on this semester they will need an additional \$1000.00 for upcoming events throughout the year; and,

WHEREAS

The requested change falls within the requirements in Article III, Section 302, so;

THEREFORE BE IT HEREBY FURTHER ENACTED

That the \$179.00 to the ASCSU Department of Governmental Affairs from Senate General Discretionary. These monies shall be line itemed as: Colorado Statesman Subscription; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the \$1000.00 to the ASCSU Department of Environmental Affairs from Senate General Discretionary. This 1000.00 shall be placed in a newly created department services: Discretionary; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the latest version of the ASCSU Executive Budget be updated accordingly; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to Katrina Roberts, Director of Finance; Gabby Greenberg, Controller; Mrs. Kim Grubbs, ASCSU Administrative Staff Assistant; and Mrs. Michele Frick, SLiCE Accountant.
