ABSTRACT: This bill is to approve the resource request from the Engineering College Council to fund their event "Engineering Days". As per the Board for Student Organization Funding Bylaws, Senate approval is needed for BSOF requests exceeding \$7,499.99.

WHEREAS

Per Article 5 Section 3.9 of the Board for Student Organization Funding Bylaws: The Board for Student Organization Funding may approve allocations, not to exceed \$7,499.99 for any one eligible organization. If a specific request exceeds \$7,499.99, it must be ratified by the Senate through a Bill following the Board's recommendation. Funding requests presented to Senate must be accompanied by an itemized budget. Any request brought forth in the form of a Bill to ratify Student Funding Board Allocations must be approved by the Senate in a viewpoint neutral manner; and,

WHEREAS

The request from the Engineering College Council is over the \$7,499.99 limit; and,

WHEREAS

The Director of Finance is forwarding the recommendation of the Engineering College Council application to the Senate for approval. The application received a vote of 7-0-0 from the Board for Student Organization Funding. Therefore; it was awarded at the full request; so,

THEREFORE BE IT HEREBY ENACTED

That \$8,885 be allocated to the Engineering College Council for their event "Engineering Days" from the Board for Student Organization Funding account to be spent in accordance with the attached budget as amended and in accordance with Student Funding Board and ASCSU guidelines; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to the Board for Student Organization Funding, Peter James Seel, Speaker Pro Tempore; Jason Sydoriak, President ASCSU; Phoenix Dugger, Vice President ASCSU.
