IX. New Business

- Bill #4615 – Changes to ASCSU Elections Code

- i. Bill 4615 was adopted for discussion

- ii. Bill 4615 was read by Speaker pro Tempore Kendall

- iii. Presentation

1. The bill before us aims to clarify some of the code in regards to the speaker of the senate position. Some of the major changes were to adding wording for the speaker of the senate.

Another change was to Section A of Article VI was to include the attendance of information sessions. The change to Article VII has a clarification to the credit requirements for the positions. Article VIII was changed to include the campaign requirements for speaker of the senate for \$750. The rest of the changes were to help clarify areas to update new forms of marketing and changes that were voted on by the body for the constitution and were not made to the Elections code.
