WHEREAS: The ASCSU office is located once more in the Lory Student Center (LSC); and,

WHEREAS: the Referenda and Elections Code is vague as to what kind of violation posting in campus buildings without permission is; and,

WHEREAS: The interpretation of Article IX Campaigning, Section O, is vague as to how 25 feet should be measured.

THEREFORE BE IT HEREBY ENACTED: That Article IX: Campaigning, Section B be amended to read, "ASCSU proper within the Lory Student Center (LSC) along with all non-election ASCSU sponsored events shall be off limits for campaigning and campaign planning of any kinds at all times; and,

THEREFORE BE IT HEREBY FURTHER ENACTED: That Article IX: Campaigning, Section I be amended to read, "The appropriate parties must approve the placement of campaign material inside any campus building. Approval to place campaign materials within the LSC must be obtained from the Campus Activities Information Desk and be placed according to LSC Governing Board guidelines. Posting campaign materials without permission will constitute a major violation. Failure to follow University building guidelines will be considered a minor violation."

THEREFORE BE IT HEREBY FURTHER ENACTED: That Article IX: Campaigning, Section O be amended to read, "No campaign material, campaign supporter, or campaigning of any kind shall be permitted within 25 feet walking distance of any official polling place administered by ASCSU. 25 feet walking distance shall be the most direct path taken by foot to the entrance. Campaigning within the restricted zones during the days of elections and referenda will constitute a major violation."
