Executive Branch

- President Eric Berlinberg
 - Past Week Follow-Up:
 - Hiring-
 - Please join me in welcoming Billy Raddell as the new Director of University Affairs for ASCSU. Billy will be up for ratification this coming Wednesday at Senate. This position will assume critical day-to-day responsibilities of the Director of Academics throughout the remainder of our Administration as well.
 - Please join me in welcoming Perdeep Badhesha as the new Deputy Director of University
 Affairs-Committees for ASCSU. Perdeep will be up for ratification this coming Wednesday
 at Senate.
 - LSC Master Plan Committee-
 - This past week, the LSC Master Plan Committee met with the architects to review their designs for the LSC renovation. We are nearing the end of the Schematic Design phase, and moving into Design Development by the end of March.
 - Tentatively, construction will begin in January of 2013 in parts of the building, with other areas unaffected until the end of Spring Semester 2013. Timelines are being finalized now. A temporary renovation plan for offices and students will be published mid-April.
 - Finance Forum-
 - This past Wednesday, we hosted our first Finance Open Forum in the Senate Chambers.
 There was a very low student attendance, but thank you to those who attended and asked thoughtful questions.
 - The next Finance Open Forum will be in mid-March. Date/time will be posted at a later date.
 - ASCSU Elections-
 - If anyone has any questions related to their interest in running for ASCSU President or Vice-President, please see Elections Manager Ives or myself. We are happy to sit down with you and answer any questions that you may have.
 - Estimated Rollover to Next Administration-
 - After going through another round of budget forecasting within ASCSU, Controller Jackson has estimated rollover at \$110,135.35. On top of this rollover figure, there are additional funds due to over-enrollment revenue generated from those students above and beyond the 23,700 that CSU requires us to budget at. The \$110k rollover number does not include Spring Semester over-enrollment revenue (which will be sent as rollover to the next Administration).
 - On top of the \$110,135.35 + Spring 2012 over-enrollment revenue, there is an additional \$100,000 of fund balance set aside per the ASCSU Constitution that is being sent to the next Administration.
 - To put these figures in perspective, the previous Administration (Cooper/Jenny) sent \$115,000 +/- to our Administration. That means that the current Administration budgeted and spent 100% of the revenue they received from student fees, plus about \$5,000 of the



rollover that Cooper/Jenny sent us. We are sending \$110,135 out of \$115,000 rollover from them to the next Administration.

- Elections Committee-
 - Thanks to Elections Manager Ives for coordinating an extremely successful Elections Committee training last week. The Elections Committee has a lot of strong members this year, and I am excited to see them begin their work.
- Transition Plan-
 - I have begun putting a tentative 'ASCSU Transition Plan' on paper, specifically related to scheduling so far. This will hopefully help provide candidates an idea of what the month post-Elections looks like, should they be voted into office.
- Goals for Next Week:
 - FY13 ASCSU Proposed Budget-
 - Controller Jackson and I are finalizing a first draft of a FY13 proposed ASCSU budget.
 This document will be very fluid between now and the start of ASCSU Elections, and will
 be provided to all candidates who are now required to have a budget meeting with the
 ASCSU President prior to being certified as a candidate.
 - This proposed budget includes the anticipated rollover figures stated above.
 - Director of Business and Financial Services/University Controller Interviews-
 - Next week I will be participating in the final candidate interviews for the Director of
 Business and Financial Services/University Controller position. There are 5 final candidates
 that were invited to campus to interview with various groups. I will be attending these
 interviews on behalf of ASCSU.
 - Stadium Advisory Committee-
 - This coming week, I will be attending several Stadium Advisory Sub-Committees, focusing on various aspects of the project.
