- VI. Guest Speakers
 - Jason Sydoriak Colorado State Police Advisory Board
 - i. I just wanted to take a moment to welcome everyone back and think that we will get a lot of work done here. I have a lot of high expectations from this body. I could talk about my initiatives for a while but will keep it brief and talk about it. In the executive branch, we are going to take a team to Todos Santos. We want to get a student perspective of the campus so we can share that through word of mouth rather than going through faculty. From now to Spring Break, we will be working on an action plan of what we are going to accomplish while at this event. U+2, we have our language and the context researched and will be starting the signature process starting here in February and ending by the time of elections. If you really want to make an impact

and participate, this is the way to do that. Director Kendall will be a major contact for this issue and contact him if you are interested. We are going to try to accomplish a police advisory board. This is more of an effort of transparency rather than a piece of legislation. People are on board with this idea and will most likely going to happen this semester. It will be a shared governance aspect for this board. Another initiative that we will be tackling will be the course survey. We have people already working on this and will be going into depth on this aspect. If you want to get involved and have your opinion voiced, talk to the academics department. - 1. Senator Rhine: What was the number of students kicked out of houses based on the U+2?
 - a. We are in contact with the city council about this aspect and have not given us any numbers. They are proactively forcing this program.
- 2. Senator Bruce: How is the funding for the legal process going?
 - a. We have exhausted the initial amount budgeted and will be looking to set another retainer that could have a refund that will come back if not used.
- 3. Senator Bryan: Could you explain the aspect of being sued for signing?
 - a. We have contracted a legal service to have a paper trail of our work and would help protect the original signers of the petition.
 - b. With the hospital provider fee, we are fifth on the list

VII. Executive Reports

• Director King: The general assembly opened on Wednesday. There will be a link on our website soon that will take you to a page about the bills and our stance on these issues. College Invest rearranges the tax aspects to create more tax deductions with investments in higher education. There is a bill that affects the microbrewing classes on campus that would allow for people of age to taste the creation of microbrews

that students have created in their class. There are a few state affairs bills that are on the floor. These bills are the most likely to die at the moment but could change. IX. Legislative Officer Reports

- Speaker Pro Tempore Seel: We would like to start off the semester with the big topics and make sure everyone feels comfortable. The first topic would be the leadership and their roles of the different branches. These will be further explained at retreat. We will move to speaking rights. Senators and Associate Senators all have speaking rights and senators have rights to voting. Any final vote on a bill or resolution has to be a roll call. These will be uploaded to the website and will be available to access by the public. We did approve iClicker votes a few months ago and is an option. You can find the Green & Gold Book can be accessed and dress code items are in that document. Electronic records are now available on the website and can reference them. Finally, we did a pass a bill that requires all of senate to fulfill sexual harassment training and have 60 days to complete that.

At this moment, there are only three internal committees and you have to sit on at least one of them.
