 - Bill #4512 ASCSU Mission Statement
 - i. Bill #4512 brought to the floor for discussion
 - ii. Bill #4512 read by Parliamentarian Miller
 - iii. Presentation of Bill
 - 1. This is a mission statement bill. This is part of my calling for being in this organization. This will hopefully bring all of us together.
 - iv. Questions
 - 1. President Sydoriak: I sent some suggestions and talk about that.
 - 2. Senator Bryan: Why is there no student's voice in the mission?

- a. I want to keep it broad so that it can be interpreted in different ways.
- 3. Senator McConnell: What about the length?
 - a. We worked on it a little more after that last meeting and made significant changes to the wording and shortened it a little bit.
- v. Discussion/Debate
 - 1. Senator Bryan: There should be some sort of governing portion
 - 2. Deputy Director Siri: I echo previous speaker
 - 3. Senator Prochazka: I like the mission statement but thinks it does need some tweaking still. We do more than writing bills.

- Res. #4513 Supplemental Funding Bill
 - i. Resolution #4513 adopted to the floor for discussion
 - ii. Resolution #4513 read by Parliamentarian Miller
 - iii. Presentation
 - 1. One thing that you won't realize is where to put the money. It is difficult of where to put the money without knowing where the initiatives will come from. We are able to correct the mistakes and fix that by giving money to the correct initiatives. This will make our organization more efficient. It give the directors to effectively spend money. Some areas that were misrepresented in funds were the elections manager, marketing, governmental affairs, health, office supplies, environmental affairs, supreme court, and office of the President.
 - iv. Questions
 - 1. Associate Senator: Does the left over money go to the other accounts?
 - a. It goes into the next administration budget
 - 2. Senator Bruce: When will we see you again if we run out of money? How can you ensure this will be different?

- a. The legal retainer fee was informing you. I can tell you that this has been one of the most conservative of the past administrations when it comes to spending money. You will not see another supplemental bill.
- 3. Senator Harrison: Why were numbers so far off?
 - a. I can't have the foresight of new initiatives. Roll overs have happened in the past and I believe that the fees that student pay now should receive the benefits from the fees. We will still be conservative. I just don't have the foresight for what will come up.
- 4. Senator Harrison: What was the roll over from last year?
 - a. It was a lot and was close to 130 thousand. We need to benefit the students now. I don't see the point for asking for more student fees.
- v. Discussion/Debate
 - 1. Friendly amendments to 1500 to the health budget and grammatical amendments.
 - a. Passed
 - Senator Lensky: They are doing a phenomenal job in their departments and have exceeded expectations. You can't allocate for that. I am for this bill.
 - 3. Senator Nolan: I am sucker for health and mental health. I have no problem pushing this through. I support a yes vote
 - 4. Gallery: The biggest changes were to marketing. She allocated her own funds to some of the departments to help them out. This would help them out. Most of the directors are creating new events such as the dinner series and this will help them continue to produce these events. You cannot really predict the future and have the money that is being discussed.
 - 5. Gallery: We did promote everyone's events. This was something that was not done last year and events were under promoted. So we decided to change that and could get everything advertised and promoted. There is a short turnaround from election to create a

budget and is hard to provide concrete figures. There is a learning curve to this process.

- 6. Associate Senator Vaishampyan: I don't think there would be a President to serve for more than one term and have those numbers figured out. He is requesting 20,000 dollars and is a small value compared to the pool. We have the money and should be using it.

 - i. Resolution #4514 adopted to the floor for discussion

 - 1. Good evening Senate. I would like to say some carefully chosen words. I read this so that I remain on point. At 11:50pm, on July 19th 2012, I walked to my midnight desk job in Parmelee to what I hoped would be an uneventful night. Instead, thirty minutes into my shift, all the new incoming students started getting texts and calls from friends, spreading the news of the tragedy that, as I learned, claimed the lives of two of my friends. I went to the memorial services, paid my respects at the site, and clung to every word of the trial of James Eagan Holmes. I am not alone who mourned. It is in my unprofessional, civilian opinion that this incident could have been avoided, but I understand hindsight is 20/20. Additionally, I lost two more friends last year to negligence with firearms while cleaning them. I think this too could have been preventable and another two memorial services that I could have avoided going to. While I lived these terrible events, suffered through them, I am also a member of the National Rifle Association. I enjoy competitions, I'm in a rimfire league, and enjoy going out to the Pawnee National Grassland to go

shooting. I'd like to think that I am a very cautious and responsible firearm owner and user since I always keep the rules in mind. This is why Senator Williams and I bring this topic to you all. There have been too many incidents regarding firearms and there are some interesting conversations going on nationwide. I think it is time to start one here and I have 104,526 reasons in two years to have this conversation. While I am biased by experience, Senator Josh Williams is more than capable of leading the discussion and make sure that it is not reduced to political polarized muck. Before we call to action, I wish to discuss which actions we can take and have many voices heard and represented. Additionally, it would be a honor to have congresspersons, representatives, mayors, and community leaders to attend and participate in this conversation, and thus, I ask you all to consider this resolution that was written by the External Committee as a whole and myself. This resolution is written with the memories of those who are not with us today. I will now yield to Senator Williams. We are open to questions and points of clarification.

 - a. That is why we kept it vague. We will add things but will be cautious of political views and limit concerns.

 - 2. Senator McConnell: Before this bill came on the floor, I was against it and after the presentation, I want to throw my support behind this resolution. We need to talk about these events in order to work to these events stopping. It could go wayside really quick so I ask everyone to be mature.
 - Director King: Before it goes to committee, I would like to see a list of what people would like to go into the resolution during the committee.
 - 4. Gallery: I would like to see ideas for policy and things to happen in the future within this aspect. I recommend you read the law that was passed in California in regards to mental health and gun safety.
