ABSTRACT: This bill aims to begin to fundamentally change the office culture at ASCSU through the writing and adoption of a new mission statement. This mission statement will be aimed at promoting organizational unity and creating a culture of inclusivity and transparency both within the office and all throughout the organization.

WHEREAS

A mission statement will express the purpose of the Associated Students of Colorado State University (ASCSU) in a manner that will inspire support and ongoing commitment to the organization; and,

WHEREAS

A mission statement provides framework and context to help guide strategies for the future of the organization; and,

WHEREAS

It is critical that all members know what ASCSU does and the direction of the future of the organization; and,

WHEREAS

Clarity of the organization's mission helps to bring direction to every other level of the organization and supports unity as well as future stability for ASCSU; and,

WHEREAS

Adopting a mission statement serves as a formal way to remind members of the organization why the organization exists and openly promotes the organization's values to the public; and,

WHEREAS

ASCSU has existed since 1907 and has never had a mission statement and the preamble in the Constitution does not do a concise job at capturing the underlying mission of ASCSU; so,

THEREFORE BE IT HEREBY ENACTED

That the Associated Students of Colorado State University adopt the following for a mission statement: "The Associated Students of Colorado State University advocate and organize for all students in order to better enhance their educational experience and provide a welcoming environment in which students can thrive".
