ABSTRACT: A Supplemental Bill to reallocate funds in order to fund line items that have presented themselves after the budgeting process was finished.

WHEREAS

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University permits the President to reallocate budgeted and unbudgeted funds as necessary as stated:

"During the course of the fiscal year the President may reallocate budgeted and unbudgeted funds, as s/he deems necessary. If the President decides to move funds between the departments that exist within ASCSU accounts, the change must be submitted to the Senate in the form of a Supplemental Funding Bill"; and,

WHEREAS

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University requires the President to seek approval from the Senate through a Supplemental Funding Bill if the funds being reallocated are between accounts; and,

WHEREAS

It is difficult to have enough foresight to anticipate all departmental funding throughout the year when first developing a budget even with the institutional knowledge provided; and,

WHEREAS

Some of the departments have spent the majority of their budget with still a semester left in the academic year and the potential of new initiatives to emerge; and,

WHEREAS

There is a substantial amount of money still left in the Senate General Discretionary, roughly \$124,984.92, that students of this year and the past year have paid into and deserve to receive the benefits of; and,

WHEREAS

The requested change falls within the requirements in Article III, Section 302, so;

THEREFORE BE IT HEREBY ENACTED

That \$1,000.00 be reallocated from Senate General Discretionary to the ASCSU Payroll. These monies shall be granted to the Elections Manager; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$10,000.00 be reallocated from Senate General Discretionary to the ASCSU Marketing Account. These monies shall be granted to the Discretionary as almost all funds have been exhausted and there is a semester still left for initiatives to be advertised; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$500.00 be reallocated from Senate General Discretionary to the ASCSU Governmental Affairs. These monies shall be granted to the Reserve for providing resources in tabling and getting students registered to vote; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$1,500.00 be reallocated from Senate General Discretionary to the ASCSU Health. These monies shall be granted to the Reserve for initiatives regarding mental health; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$3,000.00 be reallocated from Senate General Discretionary to the ASCSU Office Supplies. This \$3,000.00 shall be placed dispersed throughout the account in areas that are nearly exhausted; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the \$1,000.00 to the ASCSU Department of Environmental Affairs from Senate General Discretionary. These monies shall be granted to the Reserve for spring initiatives; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$1,000.00 be reallocated from Senate General Discretionary to the ASCSU Supreme Court. These monies shall be granted to the Reserve for their initiative of creating awareness about an individual's legal rights on and off campus; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$1,000.00 be reallocated from Senate General Discretionary to the ASCSU Senate. These monies shall be granted to the Reserve and spent as Senate leadership deems necessary; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That \$1,000.00 be reallocated from Senate General Discretionary to the ASCSU Office of the President. These monies shall be granted to the Discretionary; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the latest version of the ASCSU Executive Budget be updated accordingly; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to Katrina Roberts, Director of Finance; Gabby Greenberg, Controller; Mrs. Kim Grubbs, ASCSU Administrative Staff Assistant; and Mrs. Michele Frick, SLiCE Accountant.
