WHEREAS:	Fort Collins has over 65,000 buildings which use 85% of Fort Collins' electricity and 82% of Fort Collins' natural gas according to the Rocky Mountain Institute (RMI); and,	
WHEREAS:	RMI asserts that Fort Collins could reduce building energy usage by 31% and could save \$140 million dollars by 2030 by maximizing building energy efficiency; and,	
WHEREAS:	Building owners, particularly landlords, need an incentive to make much needed efficiency upgrades, especially in areas surrounding the CSU campus where many college students reside; and,	
WHEREAS:	Requiring all building owners who sell or lease their properties to disclose an energy efficiency rating from A, being the most efficient, to F, being the least efficient, on their advertisements would provide building owners a market incentive to make efficiency improvements; and,	
WHEREAS:	This would also provide interested purchasers or lessees valuable information regarding the expected energy costs associated with different available properties; and,	
WHEREAS:	This information can be particularly important to CSU students who often live in the least energy efficient housing, therefore paying the highest utility bills; and,	
WHEREAS:	City Council members Gerry Horak, Ross Cunniff, Bob Overbeck, and Wade Troxell have shown support for this program; and,	
WHEREAS:	ASCSU supports taking steps to improve energy efficiency in Fort Collins and in providing more information to prospective buyers and renters; and,	

WHEREAS:

This city-wide program would represent a positive first step in reducing energy inefficiencies in Fort Collins, while helping CSU students to reduce their utility bills; and,

THEREFORE BE IT HEREBY RESOLVED

That ASCSU supports the development of a city-wide program to require all building sale or lease advertisements to disclose an energy efficiency rating of A – F based on an energy audit completed by the city.
