- Resolution 4603 Adoption of ASCSU/New Era Partnership
 - i. Resolution 4603 was adopted for discussion
 - ii. Resolution 4603 was read by the Parliamentarian
 - iii. Discussion/Debate
 - 1. Amendments from committee were moved to be accepted
 - a. Senator Martin: An executive member has drafted an incident report for any partisan activity.
 - b. Amendments were adopted with a vote of 16:0:0
 - 2. Director Williams: We did draft an incident report form and will pass around. This will allow for accountability. It will be an internal procedure.
 - 3. Senator Caro: I don't agree with this partnership. I don't think it is required that we need to partner with this group with the dissent seen last week.
 - 4. Senator Martin: This resolution would be a good idea when there is no way that it will be partisan and is not a contract. Both parties will be accountable for their actions and now has a sunset clause.
 - Senator Caro: I understand that this is a non-binding agreement. They can still register people on campus and is something that is not required. This will not make people happy.
 - 6. Senator Holohan: In my opinion, a university should not partner with the propaganda that this organization has.

- 7. Senator Hansen: It is merely that this student leadership to get people to perform their one duty to vote. I think that we should get people to register to be able to perform this duty. Anything that can reach them in this action, I will get behind.
- 8. Senator Brown: Regardless of how people are going to vote, we have come together from different backgrounds and proud for the solutions that have come forward.
- 9. Senator Horowitz: I think it is important to listen to the students that were against this resolution last week. We are voting for the students.
- 10. Senator Martin: In all honesty, this is only to get voter registration. This is to get more students a part of the voting process. People wanted to get legislation done that would help the students and hope that we don't gloss over this opportunity that we have.
- 11. Director Siri: We have a position called the Director of Governmental Affairs and can advocate on higher levels. This is a way for ASCSU to go out and increase voter registration on campus. These organizations can only do so much. As ASCSU, we can bring that non-partisan view and get people to vote. If we want to pass U+2 to vote, we need these people to register to vote. This is really what it comes down to.
- 12. Senator Caro: I would like to echo previous speaker. No one is stopping us from registering people to vote. We don't need to partner with a group to do so. Maybe next year we can do better and train people and go out as ASCSU to get people to vote. I don't think we sure partner with this group.
- 13. Internal Affairs Chair Seel: When we are here in this organization, it is our job to provide a voice to students. For ASCSU to partner with a group with the experience and resources is a way to give the voice to the students. This is a campus of over 30,000 people. We are charged to give them the best chance to voice their opinion. This partnership would allow us to do that. I urge a yes.
