ABSTRACT: The purpose of this resolution is to outline the organizational structure of the new Inclusive Excellence Council created in Article V Section 503 of the ASCSU Constitution. Bill 4514 instructed the new Inclusive Excellence Council be created and language placed into Art. V Sec. 503. The further purpose of this resolution is to help perpetuate the vision of diversity within the 45th Senate by the passage of Bill 4514 and act in good faith that all concerns raised during the passage of Bill 4514 are addressed to their best ability.

WHEREAS:

The passage of Bill 4514, CONSTITUTIONAL AMENDMENT—the Diversity Bill, created many points of controversy; and,

WHEREAS:

Issues raised during the passage of Bill 4514 included a lack of complete representation of *all* under-represented groups on the Colorado State University campus; and,

WHEREAS:

Concerns surrounding the election/selection of these Diversity Senators led to irreconcilable differences on fair, open, and balanced elections of these Diversity Senators; and,

WHEREAS:

Passage of Bill 4514 added language to Article V Section 503 of the ASCSU Constitution which reads as:

"An Inclusive Excellence Council will be established to represent the particular interests and concerns of students from underrepresented populations"; and,

WHEREAS:

The Inclusive Excellence Committee—predecessor to the Inclusive Excellence Council—lacked permanence and proper support structures essential for success and therefore was unable to accomplish its goals; so,

THEREFORE BE IT HEREBY RESOLVED:

That the Inclusive Excellence Council shall be created and utilized as the appropriate college council for the Diversity Senators and act in a fashion similar to college council institutions across campus to facilitate student needs.

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That the Inclusive Excellence Council shall be tied into the Division of Student Affairs, specifically under the oversight of the Student Diversity Programs and Services office, to receive its administrative and advisory support.

THEREFORE BE IT HEREBY FURTHER RESOLVED:

Senate shall adopt the proposed model and Inclusive Excellence Council Constitution, which creates an Advisory Board within the Inclusive Excellence Council, to better represent all other under-represented student groups.

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That the proposed model and Inclusive Excellence Council Constitution, which the directors of the SDPS offices and the Director of ALVS has delegated authority to, carries out the responsibilities of election for the several Diversity Senators and Associate Diversity Senators.

THEREFORE BE IT HEREBY FURTHER RESOLVED:

That this Forty-Fifth Senate of the Associated Students of Colorado State University endorse the creation of the Inclusive Excellence Council set forth in the proposed provisions of the Inclusive Excellence Council Constitution.

THEREFORE BE IT HEREBY FURTHER RESOLVED:
