- Resolution 4614 In Support of Our Students Trapped Abroad

- Resolution 4613 Solidarity with Standing Rock
 - i. Resolution 4613 was adopted for discussion
 - ii. Resolution 4613 was read by Parliamentarian Vaishamapayn
 - iii. Committee Changes
 - We added more people to the endorse by list. Some of the major changes were changing territory to sovereign land.
 There were also other grammatical errors that were changed.

 - iv. Discussion/Debate

- 1. Senator Eftink: I polled the college council I represent. My college council was in favor of the bill.
- 2. Senator Pyfrom: I echo previous speaker about polling the constituents. They were not in favor of it.
- 3. Senator Tayah: This is an ASCSU issue as it affects students
- 4. Senator Horowitz: We are here to represent the entire student body. As we are representing 39,000 students. We shouldn't take a stance on this issue. It should be done on an individual level or club level. It shouldn't be done by the student government.
- 5. Senator Brown: I have to urge a no vote on this resolution. This is a politically charged issue. We should be cautious about human rights and where does that stop. I urge you to consider the polarizing issue that we have in front of us and like the idea of a vote to the student body.
- 6. Senator Griffith: All voices matter. We are telling that these students don't matter. We need to vote yes on this.
- 7. I understand the political aspect. By supporting this, it shows that we recognize the treaty rights that established.
- 8. Senator Hughes: I call for previous question
 - a. Motion fails
- 9. Senator Martin: This resolution needs to be passed. If we are going to represent all students, we need to pass this and not glance over others. It is time for us to stop being afraid. I urge a yes vote tonight.
- 10. Senator Sanford: I would like to echo previous speakers in favor of this bill
- 11. Senator Pastor: There are a lot of nasty stuff that is happening to the protestors there and urge a yes vote.
- 12. Senator Auer: The personal is political and the political is personal. Violence to protestors should not be controversial. I urge a yes vote
- 13. Senator Royer: If try to represent small groups, where does that stop. I believe that we are getting too emotional with this issue. We aren't able to do anything besides that we support something.

- 14. Senator Horowitz: I move to remove the second to last therefore clause of the resolution.
 - a. Made as a friendly amendment
- 15. Senator Brown: I think that we need to upstand the professionalism of this body.
- 16. Senator Tayah: I want this to pass. It has a big impact. I urge a yes vote.
- 17. Senator Martin: I urge a yes vote. Every student needs t obe heard.
