iii. Committee Changes

1. Some of the major changes to this resolution were grammatical changes. Some of the bigger changes to the resolution are later on in the document. We made changes to the credit requirements to cover situations that may arise with transfer students and graduation dates.

iv. Discussion

1. Motion to approve amendments

a. Senator Henshaw: I find that the removal of credit requirements concerning. I feel that people should have more experience with the university.

b. Senator Martin: I don't think that experience should be a limiting factor on what they can do.

c. Senator Stott: I urge a yes vote

d. Senator Murray: I like the bill now with the changes.

e. Senator Pyfrom: I agree there is an issue with transfer students. I do think that there should be some limit of credits required. I think that the 60 may be too high.

f. Associate Senator Rosenthal: I think that this is an opportunity to get new student involved.

g. Associate Senator Salcedo: I believe that university is a place to gain experience and not to require experiences.

- h. Senator Hart: We should make the clarification made to who it is tailored to.
- i. Senator Henshaw: I think there are other options to get first year students involved in ASCSU and not in executive roles. I am still not comfortable with the removal of credit requirements.
- j. Senator Ruiz: First year students does not mean 18 year olds as we have nontraditional students.
- k. Senator Murray: I move to amend the current amendments by changing the credit requirements to 24 credits for vice president and president and 12 credits for speaker of the senate. Graduate students would be exempt from this requirement.
