A report entitled The Experiences and Perceptions of Campus Climate for Women Faculty at Colorado State University by the Standing Committee on the Status of Women Faculty (SCSWF) in Spring 2017; and,

# **WHEREAS**

At Colorado State University the Campus Climate has developed, as described in the report's first theme, "Persistent Gender-Based Inequities."; and,

# **WHEREAS**

Data was collected through the use of focus groups, interviews, and surveys across campus women faculty representing 12% of that population; and,

### **WHEREAS**

This report takes the experiences of women faculty and translates them into general themes which describe issues in campus climate and tangible recommendations to create remedies to those issues; and,

The conditions that affect faculty at Colorado State University directly impacts the education that students receive and the Associated Students of Colorado State University recognize that students can have an impact on campus climate; so,

That the Associated Students of Colorado State University recognize the work done to produce this report and the results and recommendations offered; and,

That ASCSU will endeavor to find ways that students can assist in reaching the recommendations suggested by the report; and,

#### THEREFORE BE IT HEREBY FURTHER RESOLVED

That further research should be done to evaluate what resources need to be provided for all people that are deeply affected by the inequities described in this report; and,

That ASCSU asks the Colorado State University Administration act upon the recommendations and research done in this report to alleviate these inequities; and,
