 - Bill #4620 RATIFICATION OF THE EXECUTIVE JOB DESCRIPTIONS
 - i. Bill #4620 was adopted for discussion
 - ii. Bill #4620 was read by Parliamentarian Vaishampayan
 - iii. Discussion/Debate
 - 1. Vice President Lensky: I would like to have some discussion about the pay levels. We had issues last year with the structure that we had for pay levels.
 - Vice President Elect Wells: We looked at these through the payroll. We did see that concern last year. The directors and officers can see some consistency based on pay and hours expected.
 - 3. Senator Auer: wanting to have an unbiased and free of party affiliation group to help with voter registration; suggesting two or more entities coming to ASCSU and us deciding what the most unbiased entity is

4. President Elect Silva: last year was a time constraint to find a nonbiased group, hoping to have more organization next year in choosing a nonpartisan voter registration group

iv. Presentation

1. Academics

- a. Similar to last year with changes to pay and chairing board under job duties.
- Pacesetters scholarship has moved to the academics department.

2. Campus Engagement

a. Retains a lot of the responsibilities of former
 Outreach departments. This branch will focus on volunteering and a positive presence on campus.

3. Diversity and Inclusion

 a. This position will work to host more workshops, symposiums, etc. in diversity related content.

4. Environmental Affairs

a. This job is very similar to the current job and the only change is having the director be an at large representative for ATFAB.

5. Finance

a. This department is staying very similar to the current format.

6. Graduate Affairs

 a. This office is a breakout from University affairs to focus more on the graduate population. We want to create a pilot program to host a graduate focused event with traditions and programming

7. Health

a. This department will contain most of the same responsibilities of last year. We updated the definition of health to include more than just physical.

8. Innovation and Technology

 a. This is a new department. It would be an officer pay. It would be based on promoting new technologies around campus.

9. Marketing

- a. Marketing strategy
 - More of the strategy and less of the media and art work. It will be more focused on the strategy and streamlining that message through all channels.

b. Multimedia

i. This is a director position that is combined with the current videography position. This position is focused more on content.

c. Graphic Design

This became a full director with the
workload that comes with the position. It is
focused on the design of advertisements.
We wanted to have this position be more
competitive with similar jobs across campus.

10. President's Office

- a. Chief of Staff
 - i. Minor changes

- a. Governmental Affairs
 - Director position. Duties have not changed much. Voter registration would be a continual duty. Day at the capitol would be a highlight event for the position

b. Community Affairs

- i. Officer position. Similar to what is currently seen.

a. Not many changes to current structure. The collaboration with graduate affairs would be a new duty. There would be two deputy directors with specific focuses in this department.

- Bill #4622 Updating the ASCSU Elections Code
 - i. Bill #4622 adopted for discussion
 - ii. Bill #4622 read by Parliamentarian Vaishampayan
 - iii. Presentation of Bill
 - 1. This bill will help define and clarify social media and other code to make it easier to understand. Election Committee will meet once a day during the voting period. Violations of stated problems are now clarified in the process. Final reports submissions now have a time requirement to allow for review. Third party groups cannot campaign for a ticket and will then go on reports. University resources cannot be used for campaign resources. Club sports are allowed to endorse campaigns. Morgan Library and other places are added to places of no campaigning. There is an update for no bribing for voting. This is prohibited but now clearly stated. The fining process is now clarified for how those work.

- 1. Senator Henshaw: what occurs if a fine is issue to a campaign that exceeds the limit.
 - a. They are expelled from the campaign race.

- 2. Senator Henshaw: What does this bill do?
 - a. It removes the petition process. We did not come up with an effective process to replace it. We decided the best option would be to just remove the process.
- 3. Senator Horowitz: Is there anything stated about these requirements?
 - a. It is not explicitly stated as I did not see the need to do that. I am open to the idea of adding that wordage.

document from the last weekly report for the document. This is a rough draft of the budget and we will have some amendments to be made in committee. All of the earmarks in the Office of the President are the same with pilot programs making an effect.
