# FUNDING TO HOST FORMER EPA ADMINISTRATOR GINA MCCARTHY IN COLLABORATION WITH THE OFFICE OF INTERNATIONAL PROGRAMS

ABSTRACT: This bill seeks to allocate sufficient funding to sponsor the attendance of Former Administrator of the Environmental Protection Agency, Gina McCarthy, at a campus-wide speaking event in collaboration with the Office of International Programs.

#### WHEREAS

Over the past three-years the Associated Students of Colorado State University (ASCSU) and the Office of International Programs (OIP) have collaborated to bring prominent speaking events to campus; and,

#### WHEREAS

In previous years this collaboration has yielded events involving heads of state and noble laureates who have honored the University through their message and presence; and,

## **WHEREAS**

The value of these truly unique events belong to all students and ASCSU engagement ensures that campus partners are able to share this experience with the most students and to ensure the continued presence of these events into the future; and,

#### **WHEREAS**

For the 2017-2018 year, the Office of International Programs in collaboration with on-campus partners would like to bring Gina McCarthy, the 13<sup>th</sup> Administrator of the Environmental Protection Agency to campus for a speaking event; and,

#### **WHEREAS**

The Senate General Discretionary exists to give the Associated Students of Colorado State University (ASCSU) Senate the flexibility to take advantage of these one-time opportunities that greatly benefit our students; and,

# **WHEREAS**

Because of the diligence of OIP fundraising efforts, they have the support of numerous community partners to provide logistical support and share expenses, reducing the cost requested of ASCSU to \$4,000 which is less than 9% of the total cost of the event; so,

# NOW THEREFORE BE IT HEREBY ENACTED

That the \$4,000 needed to host Administrator McCarthy be pulled from the Senate General Discretionary wherever it may reside and utilized for this event; and,

# NOW THEREFORE BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to the ASCSU Director of Finance, the ASCSU Controller, the ASCSU President, Shauna DeLuca of the Office of International Programs and Kim Grubbs, ASCSU Administrative Assistant and Adviser.
