ABSTRACT: A supplemental funding bill calling for the modification of the Officer of Community Affairs position to be revised to a Director of Community Affairs, with a corresponding stipend increase from \$6,500 to \$8,000.

WHEREAS

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University states that “If the President decides to move funds between the departments that exist within ASCSU accounts, the change must be submitted to the Senate in the form of a Supplemental Funding Bill”; and,

WHEREAS

Article III, Section 302 of the Constitution of the Associated Students of Colorado State University states that “The bill shall be written and presented by the ASCSU President and/or his/her designee”; and,

WHEREAS

Article VIII, Section 801 of the Constitution of the Associated Students of Colorado State University states that “Funds may be transferred between ASCSU departments by the President,

only with the approval of Senate in the form of a Supplemental Funding Bill that shall be written and presented by the President”; and,

WHEREAS

The requested change falls within the requirements listed above; and,

WHEREAS

The Office of the President is seeking to make payroll changes to the Department of State and Local Policy; and,

WHEREAS

The proposed change is an effort to compensate for the increased scope and weekly workload the position has come to entail; and,

WHEREAS

This Cabinet position now involves a significant unforeseen time commitment to collaborate with the City of Fort Collins regarding student participation and input in the rewrite of the City Master Plan and Transportation Plan; and,

WHEREAS

This Cabinet position now involves collaboration with the ASCSU Senate in a legislative affairs working group; and,

WHEREAS

The Officer of Community Affairs has faithfully executed and far exceeded tasks and duties assigned by the President, Vice President, Chief of Staff, Deputy Chief of Staff, and the original job description; and,

WHEREAS

The amount of hours on the current job description for Office of Community Affairs is equivalent to the hours expected for a Director position; so,

THEREFORE BE IT HEREBY ENACTED

That the Officer of Community Affairs position be renamed the Director of Community Affairs; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the stipend for the Director of Community Affairs be revised from \$6,500 to \$8,000 annually, in accordance with the Director stipend rate set by the President with the consent of the Senate in the ASCSU budget; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the payroll changes be reflected in the 2017-2018 ASCSU Controller Book; and

THEREFORE BE IT HEREBY FURTHER ENACTED

That the job description for the position be revised to include stated changes; and,

THEREFORE BE IT HEREBY FUTHER ENACTED

That \$1,500 be moved from the Senate General Discretionary account (2362500) to the ASCSU payroll account (2361400) to cover the additional amount of compensation needed; and,

THEREFORE BE IT HEREBY FURTHER ENACTED
