Chair Brown: (moves to approve Consent Agenda, passed by unanimous consent)

**Gallery Input** 

Chair Brown: Do we have any gallery input? Seeing none we will move into guest presentations.

<u>Guest Presentation – ASCSU Contracts by President Silva</u>

President Silva: The reason I wanted to present tonight is there is a section in the constitution. Can everyone hear me, I think I am too far away. There is a section in the constitution regarding keeping senate updated on contracts. We have the USA Today readership contract that was approved last spring and the other one is the RMSMC contract. These are both pretty standard but we are in a little bit of a different situation these year versus what we budgeted and what we are paying out. We didn't ask for a fee increase this year but we decided that this would come from the rollover instead. Michael and I met with them to discuss their coming needs for the year and the contract, a multiyear operating agreement that has been in effect for a few years now, negotiated under my predecessors. This one currently stipulates an increase and after consulting with our accountants we will have a large rollover. We will look at writing a supplemental funding bill to pull from the fund balance as most fee areas do. I would be happy to answer any questions you have now.

Chair Brown: Questions for the presenter?

**Senator Henshaw:** Can you go into more detail on the RMSMC budget and whether things were overlooked?

**President Silva:** It wasn't quite overlooked it's just that back in April this amount wasn't quite finalized. This amount covers inflation, rent costs and wage increases.

Senator Schmidt: The RMSMC is the Collegian?

President Silva: RMSMC is an independent organization including Collegian, CTV, 90.5 and other media.

Senator Schmidt: So, you have this contract in place, how long is this for at the current signing?

**President Silva:** It's an operating agreement that operates over multiple years and the funding portion is negotiated yearly.

**Senator Schmidt:** What would occur if we did not approve this contract?

**President Silva:** They would operate based on the operating agreement as it currently stands.

**Adviser Mann**: Can you talk about the timing for when this was negotiated as well as what was put in the agreement moving forward as it relates to next year.

**President Silva:** We presented our budget the week after the election but were unable to meet with RMSMC till a week or so after that. Something we put in the contract this year was meetings earlier so that we can in future years ensure that there is no drop such as information in orientation to candidates. As you said the timing was very hard this year so we needed to do our best estimate and didn't have the exact amount.

Associate Senator Siri: How big of a shortfall is this or how much are we pulling from BSOF.

**President Silva:** So, we are not pulling from BSOF we are pulling from the fund balance, \$32,500, which is part of the \$65,000 rollover.

**Senator Williams:** To my knowledge fund balances are only supposed to be pulled from in extreme emergencies. Also, is it sustainable to be pulling from this fund.

**President Silva:** So, there is two parts, 1 If it is sustainable and... So, over the summer Michael and I talked about what is sustainable. We looked at projecting for when things are short or way over and no, this isn't sustainable but that is why we put into the contract those earlier meetings so that this can be managed better. So, what was the second part?

**Senator Williams:** So is this an emergency situation.

**President Silva:** I think it is important that we uphold our word, but I am open to the idea of pulling it from other areas, the rollover currently sits in this account.

**Senator Lindell:** What justifies this increase?

**President Silva:** This accounts for state mandated minimum wage as well as increases in rental. We also are funding a pilot program in the fall for a creative adviser to produce better content in large quantities.

Officer Sullivan: So, you are proposing that we increase the funding by \$32,500?

**President Silva:** The idea is that we have that bill to reconcile the line item so it matches what the contract says versus what we estimated.

Officer Sullivan: So, what is the total cost?

**President Silva:** \$585,711 which is different than the \$618,000 that the contract accounts for.

Officer Sullivan: So, they are an independent organization?

President Silva: Correct.

**Chair Brown:** Any other questions, no then we will move into executive reports.

## Reports

**Chief of Staff Wise:** I, director Royal and President Silva are finishing the interviews for the Deputy of environmental affairs and will announce that Friday.

**Deputy Chief of Staff Lakey:** If you are a junior or senior there are three \$1500 scholarships under the pacesetters tab on the website.

**President Silva:** I was contacted by faculty council, they are trying to fill several spots with graduates and undergraduates. These are very influential committees that student engagement is important on. It is a great way to get a good perspective of how the university work and I will send a list out by email.

**Director Syron:** I am speaking to you as a college council president. I am doing an impeachment form here. I am recommending an impeachment of Nick Bodane for not contributing 3 hours a week, not attending enough weekly senate sessions and failing to attend the college council and internal committees and legislation for college councils. I have reached out to him by email and got no reply. I recommend the speaker impeach him or this body does. The council is ready to move on.

Chief Justice Anderson: Opinion 4703, clarification of the code of ethics, impeachment petition procedures. Josh Silva requested clarification on many of the governing documents including constitution 600. ASCSU Code of ethics do not need to be filed and acted on before impeachment is presented, however the court does agree that they should be filed and acted on before the Senate should begin impeachments second week. Secondly, acting upon in 601, describes whether or not the court describes to hear a complaint. Thirdly, the court believes the legislative and judicial branch goes through two separate process. Even after a complaint goes through the judicial the Senate may determine whether to move forward on their own even if an internal complaint has been filed and acted on. Finally, regarding duplicates in section 601 and 600 we refer to opinion 4702 which already has been rendered and sets precedent.

**Chair Brown:** Any committee reports?

**Senator Martin:** So, in external committee today we have elected our secretary and vice chair. Vice Chair Senator Nordstrom and Secretary Kattie Hagstrom.

**Senator Lindell:** We started our committee with a presentation on composting and hopefully we can put that into bill form. We also elected Senator Kingsley as our Vice Chair.

**Senator Cheadle:** We elected Senator Bunting as our Vice Chair and Senator Draper as our scribe as well as doing grammar edits.

Chair Brown: Any officer reports?

**Speaker Pro Tempore Rosenthal:** I encourage you all to come up to us and seek any help you need in bringing these ideas to fruition.

**Parliamentarian Vaishampayan:** If you need a placard come talk to me. In different business, I got all the legislation that the 46<sup>th</sup> Senate considered if you want to see all the legislation we considered come see me and I can get your paper copies before I ship them off to archives.

**Chair Brown:** I have two announcements, thank you for filling out the doodle poll, I will place paper assignments on the door tonight. If you haven't you must fill that now since you are missing that office hour. The other thing is regular training days with new members next Thursday.

**Senator Nordstrom:** I would like to clarify a couple things regarding the opinion piece in the collegian. I started this as a third party. I like Josh but could not stand by as unprofessional behavior occurred. The Senate is the students voice and approval and none was given. Harassment, yelling in the office and the

threat against firing was supposedly occurring in the office. It was brought to my attention that things acting on ethics violations should be run through the supreme court; my internal complaint was heard but an old document was found that changed hearing procedures and so they must be reheard. I resubmitted it but a University official stepped in a requested my evidence. With the evidence collected it is just a matter of time before consequences are enacted. Even with OEO it is important that we consider these violations even when they have been afraid and hurt. We owe it to the student body. We believe in process over politics, transparency to the student body and more than political games. I have my finalized, or third attempt at submitting this petition. My petition sites a previously acted upon ethics violation. (Request document for full verbatim text.
