ABSTRACT: Declaration support of the constitution autonomy of both CUSG and ASCSU and submitting a formal offer of alliance to CUSG.

WHEREAS

We are all students; and,

WHEREAS

Student government autonomy is the foundation of responsible student fee administration; and,

WHEREAS

The power of the students to govern themselves has been and always should be a defining feature of American colleges; so,

THEREFORE, BE IT HEREBY RESOLVED

That ASCSU and the students of Colorado State University formally declare full support of CUSG in their endeavor to maintain student power and autonomy; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That ASCSU and the students of Colorado State University formally extend and offer of alliance to CUSG to combine our legislative influence in the Colorado General Assembly and combat the efforts to strip the students of their rights of self-governance; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That ASCSU extend an invitation of coalition to the Associated Students of Colorado State University Pueblo, the University of Northern Colorado Student Government, the Undergraduate Student Government of the Colorado School of Mines, the Associated Student Government of Colorado Mesa University, the Metropolitan State University of Denver Student Government Assembly, the Student Government Association of the University of Colorado - Colorado Springs, the Student Government Association of the University of Colorado - Denver, the Undergraduate Student Government of the University of Denver; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That the Senate designate 3 members, one from each branch, of ASCSU to pursue and actively oversee ASCSU's efforts of coalition building; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That this be ASCSU's formal stance and goal, and that this Lex remain in effect until nullified by another Lex or the goal has been achived; and,

THEREFORE, BE IT HEREBY FURTHER RESOLVED

That this resolution be forwarded to all the legislative and executive branches of each student government stated above.
