The President shall prepare an Executive budget, which shall be submitted to the Senate for deliberation and apportionment, with no more than 22% of the total budgeted expenditures allocated for salaries, excluding the ASCSU Administrative Assistant any any non-ratified positions, as defined by Article I, Section 106 (b); so

That the 53rd Senate of the Associated Students of Colorado State University approve the 2023-2024 ASCSU Budget.
