ABSTRACT: This lex seeks to remedy a mistype of a change to the Constitution from the 50th Senate.

WHEREAS

Bill 5019 “Adding Diversity and Inclusion to the Constitution” added Section 106: Diversity and Inclusion, to the Constitution; and,

WHEREAS

The University Affairs Committee made the change to section 209 (d) that “The training is up to the discretion of the Speaker of the Senate or by the request of at least two ASCSU Senate Committee Chairs”; and,

WHEREAS

The change to add that any two Committee Chairs can require this training was meant to be added to requiring ANY training to all members even those with ex-officio status, but this was added to the bottom of the document, thereby misplacing the change; and,

THEREFORE BE IT HEREBY ENACTED

That Section 106 Subsection D (i) be amended to state “All members with speaking rights, including ex-officio members as defined by Article II Section 209 (c) of this document, must take all training deemed necessary for the Legislative Branch by the Chair or any two ASCSU Committee Chairs to maintain their speaking rights”; and,

THEREFORE BE IT HEREBY RESOLVED

That the 51st Senate of the Associated Students of Colorado State University recommit to working toward Diversity, Equity, and Inclusion; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to Joyce McConnell, Colorado State University President; and Tony Frank, CSU Chancellor; Christian Dykson, ASCSU President; Jackson Hunter, ASCSU Parliamentarian;
