ABSTRACT: A change that will extend the sunset clause of Bill 5022 (The Good Neighbor Program Bill) due to a delayed hiring start date of the Property Management Liaison

---

WHEREAS

On April 21, 2021, the 50<sup>th</sup> Senate of ASCSU unanimously passed Bill 5022 which invested \$125,000 to create the Property Manager liaison, which oversees the Good Neighbor Program housed in Off-Campus Life; and,

WHEREAS

Stevie Jorgensen, the Property Liaison Manager was hired on January 1, 2022 – 6 months after the originally anticipated hire date; and,

WHEREAS

The first therefore clause of Bill 5022 reads:

“That \$125,000 of the fund balance be allocated to the State and Local Policy Department Discretionary Budget to fund the Good Neighbor Program through Off-Campus Life. The \$125,000 will be spent over two years (FY22 and FY23)”; and,

WHEREAS

The alteration to the sunset clause, as proposed below, is simply a mechanism to ensure that the funding originally allocated can be fully utilized by Off-Campus Life. It will not change the dollar amount allocated to the Property Manager Liaison; so,

THEREFORE BE IT HEREBY ENACTED

That the Fifty First Senate of the Associated Students of Colorado State University officially agree to extend the allocation of funding from Bill #5022 to the Fiscal Year 2024. All remaining funds will be returned to the ASCSU General Discretionary Fund; and,

THEREFORE BE IT HEREBY FURTHER ENACTED/RESOLVED

That a copy of this legislation be forwarded to Joyce McConnell, Colorado State University President; Dr. Blanche Hughes, Vice President for Student Affairs; Lindsay Mason, Director of Off-Campus Life; Stevie Jorgensen, Property Manager Liaison at Off-Campus Life; Benton Roesler, Housing Director of ASCSU.
