ABSTRACT: This bill aims to change Diversity and Inclusion Caucus into Diversity, Equity, and Inclusion Affairs Committee to ensure that all bills, resolutions, and leges are looked at meticulously through the lens of Diversity, Equity, and Inclusion making sure that it upholds the universities initiatives of fostering a diverse, equitable, and an inclusive community in all aspects across campus.

WHEREAS	The CSU Principles of Community states that, "We have the right to be treated and the responsibility to treat others with fairness and equity, the duty to challenge prejudice, and to uphold the laws, policies and promote justice in all respects."; and,
WHEREAS	The CSU Principles of Community states that, "We are accountable for our actions and will act ethically and honesty in all our interactions." and,
WHEREAS	ASCSU is a body that seeks to "represent a student body comprised of a multitude of individuals and cultures, linked by our common denominators, yet distinguished by our unique experiences," according to the Preamble of the ASCSU Constitution; and,
WHEREAS	In Section 602 of the Constitution Article E: Article E: "Once ratified by the Senate, a caucus becomes a permanent entity. i) A caucus end date can be stipulated by the legislation which created the caucus originally."; and,
WHEREAS	With the clause under Section 602 in the Constitution stating that caucus can be removed through a resolution that would add an end date to the caucus which conveys that if done correctly DnI Caucus could be removed; and,
WHEREAS	With the creation of the Diversity, Equity, and Inclusion Affairs Committee, also known as "DEI Committee," ASCSU Senate upholds the Principles of Community by creating a space that challenges any hidden prejudice and confirm that bills are structured to be equitable, inclusive, and diverse for every student; and,
WHEREAS	A major difference in Committee and Caucus is that legislation must go through Committees and be reviewed in order to reach the Senate floor, while with Caucuses legislation can be looked at, but they have no authority when asking for changes; and,
WHEREAS	The importance of Diversity, Equity and Inclusion being present in legislation helps serve not only the students, but staff, faculty, and others as well; and,
WHEREAS	

	The jurisdiction of the University Affairs Committee is "pertaining to the University-wide student needs and concerns, as well as any matters relating to building external partnerships with local, state, and federal governments in order to respond to CSU student needs or concerns." This makes it too broad to look at legislation specifically with DEI in mind; and,
WHEREAS	
	The Diversity, Equity and Inclusion Affairs Committee's jurisdiction differs from University Affairs Committee's jurisdiction by having the lens of this committee specifically for Diversity, Equity, and Inclusion and instead of it being student needs for the university this address student needs for their identities and helping to create equitable resources
WHEREAS	
	The 52nd Senate passed Resolution #5202, Dedication to Diversity, Equity, and Inclusion on September 21st, 2022 promising to uphold diversity, equity, and inclusion within the ASCSU space. This Resolution passed 33-0-2; and,
WHEREAS	
	Diversity is a measure of how an individual's personal characteristics differ from those of the normative majority of an organization. Inclusion is the act of ensuring that people's experiences within an organization are not impacted negatively as a result of their personal characteristics and,
WHEREAS	
	It is important to acknowledge the difference between Equity and Equality. Equity means that everything must take fairness and justice into account. It means that not everyone comes from the same place, so we must acknowledge and make adjustmenst to any imbalances. Equality means that the same must be provided to all; and,
WHEREAS	
	Through a brief search, Colleges have implemented their own Committees centered around Diversity and Inclusion; and,
WHEREAS	
	Seen in many Senates there is a lack of diveristy when it comes to the Senators and Legislative Cabinet which doesn't properly represent the diverse populations in each college so with the creation of this committee it aims to rectify that imbalance; and,

#### THEREFORE BE IT HEREBY ENACTED

That Section VI of Article B of the Senate Bylaws shall be amended to read as followed: "Article B: There shall be four [4] Senate Internal Committees known as the Internal Affairs Committee, University Affairs Committee, Budgetary Affairs Committee, and Diversity, Equity, Inclusion Affairs Committee"; and,

## THEREFORE BE IT HEREBY FURTHER ENACTED

That the Diversity, Equity, and Inclusion Affairs Chair will be subjected to follow the ASCSU Committee Chair Job Description and is entitled to the compensation outlined with University & Internal Affairs Chairs; and,

# THEREFORE BE IT HEREBY FURTHER ENACTED

That Diversity, Equity, and Inclusion Affair Committee shall be a permanent part of the ASCSU Committees and cannot be removed; and,

## THEREFORE BE IT HEREBY FURTHER ENACTED

The Bylaws of the Diversity, Equity, and Inclusion Affairs Committee will be written and voted on by the committee at the latest of its second committee meeting.

# THEREFORE BE IT HEREBY FURTHER ENCATED

For the 2022-2023 fiscal year the chair will only be paid half of the amount due to the mishandling of funds in the 2021-2022 fiscal year to ensure an adequate fund balance and will be paid through the Senate discressionary fund.

## THEREFORE BE IT HEREBY FURTHER ENACTED
