ABSTRACT: This bill will ensure funding to enable the successful and sustainable creation, implementation, and operation of the Temporarily Disabled Students Transportation Program from the Senate Discretionary Fund.

WHEREAS

The goal of this program is to equip temporarily disabled CSU students with a viable and easily accessible mode of on- campus transportation to minimize the impacts of temporary disabilities upon students' health, welfare, and academic potential; and,

WHEREAS

This program will be operational each day the university is in session during the fall and spring semesters from 8:30am- 4:30pm; and,

WHEREAS

This program will be an addition to RamRide and will be implemented, coordinated, and managed by the CSU office of Off- Campus Life; and,

WHEREAS

According to inputs and testimonies from a recent survey regarding the need of this program on the CSU campus, current issues facing temporarily disabled CSU students tasked with navigating the CSU campus include adverse effects upon education, mental, physical, and social wellbeing; and,

WHEREAS

In the aforementioned recently published survey, 45.7% of respondents stated that they have been faced with navigating the CSU campus while temporarily disabled. 100% of those respondents stated that if this program had been implemented at that time, their educational, mental, physical, and social wellbeing would have been significantly better—both during and after they found themselves temporarily disabled; and,

WHEREAS

In the aforementioned recently published survey, 100% of respondents stated that if they found themselves tasked with navigating the CSU campus while temporarily disabled, this program would be imperative to their educational, mental, physical, and social wellbeing; so,

THEREFORE, BE IT HEREBY ENACTED

That \$3,040 be moved from the ASCSU Senate Discretionary Fund into the Office of Off-Campus Life ("OCL") Account to fund the rental of one golf cart daily each day that the university is in session during the fall and spring semesters from the CSU motor pool managed by Parking and Transportation Services; and,



THEREFORE, BE IT HEREBY FURTHER ENACTED

That \$1,350 be moved from the ASCSU Senate Discretionary Fund into the OCL Account to fund purchasing of driver equipment, including, but not limited to a used cellphone, coat, gloves, hat, and hand warmers; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That \$1,000 be moved from the ASCSU Senate Discretionary Fund into the OCL Account to fund marketing and publicity initiatives relating to the program in question including, but not limited to advertisements in the Collegian, advertisements on campus TVs, flyers and posters in residence and dining halls, advertisements through the CSU Health Network, and handouts for local doctor's offices and hospitals; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That \$5542.79 be moved from the ASCSU Senate Discretionary Fund into the OCL Account to fund a 10% operating and unforeseen costs safety buffer for the program in question. Any amount of this safety buffer fund that is not used by the CSU Office of Off- Campus Life towards the implementation, coordination, or operation of the program in question will be assessed at the end of each school year in a program stakeholder meeting and returned to the ASCSU Senate Discretionary Fund; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That \$1,065 be moved from the ASCSU Senate Discretionary Fund into the OCL Account and be equally distributed in amounts of \$355 to fund the driver salary, office of Off- Campus Life Assistant Director supplemental pay, and office of Off- Campus Life Student Employee Salary for the program in question; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

That an exact copy of this bill be presented at the 5th Senate Session of each year for four years to allocate the aforementioned amounts (\$3040, \$1350, \$1000, \$5542.79, and \$1065, totaling \$11997.79) be to the OCL Account to fund the following school year for four years, beginning in March of the 2022/23 CSU school year. This action will be overseen by Braxton Dietz (braxtond@colostate.edu) and the ASCSU Senate Budgetary Affairs Committee Chair (ascsu_senate_budgetary_committee@mail.colostate.edu) on behalf of the ASCSU Senate in coordination with Lindsay Mason (lindsay.mason@colostate.edu), or whomever may be the CSU office of Off- Campus Life Director at that time.

THEREFORE, BE IT HEREBY FURTHER ENACTED

That the aforementioned amounts (\$3040, \$1350, \$1000, \$5542.79, and \$1065, totaling \$11997.79) be reassessed by the ASCSU Senate for continuation, increasement, nullification, or reduction at the end of the aforementioned four-year period in a meeting with the Director of the CSU office of Off- Campus Life and all program stakeholders.



THEREFORE, BE IT HEREBY FURTHER ENACTED

That a representative shall be designated by the ASCSU Senate to coordinate relations between the ASCSU Senate and the CSU office of Off-Campus Life as it pertains to the program in question. This representative shall be nominated by anyone within the body and designated by the ASCSU Senate through a vote in form the body's choice during the final reading of this legislation.

THEREFORE, BE IT HEREBY FURTHER ENACTED

That the aforementioned representative shall write a memorandum of understanding between the ASCSU Senate and the CSU office of Off-Campus Life outlining the rules and regulations involving the two parties' working relationship and the aforementioned funding as it pertains to the program in question.

THEREFORE, BE IT HEREBY FURTHER ENACTED

It's extremely difficult to navigate campus, especially during busy times. I had to miss multiple classes because I physically couldn't get there. This would've been extremely helpful and I'm really grateful you're considering it!"

I had to utilize the ride service with SDC (maybe they don't have this at all anymore?) but it was extremely limited and not particularly functional (still very grateful for the amount it did make things easier for me). I also had a student who broke his leg and was on crutches an entire Spring semester (winter weather!) and recommended this service to him, and he mentioned several times (and this is a very positive student) just how challenging it was to get around campus and how arduous the process was to utilize the ride service and it's many limitations."
