ABSTRACT: Changes made to the LSAB bylaws for next year

WHEREAS

These are the changes made to the LSAB Bylaws. And,

THEREFORE, BE IT HEREBY ENACTED

In Article 3, these have been added, four students who are not members of the three branches in ASCSU, and Students not in the 3 branches will be chosen by the Chairs of LSAB and ratified by the ASCSU Senate. As well this now needs to be done by the fifth week of the fall semester.

The second section of this article has been removed. And,

THEREFORE, BE IT HEREBY FURTHER ENACTED

In Article 4, there have been added. The Chair will be the head of the Department of Governmental Affairs or whatever department handles this. In Section 2: Vice Chair

The Vice Chair will be chosen by the Chair. They will have voting rights unless they are chairing a meeting if the Chair is unable to. And,

THEREFORE, BE IT HEREBY FURTHER ENACTED

In Article 5 this has been added, In Section 1, The Board shall meet once per week during the academic semester or at the discretion of the Chairpersons(people). In Section 2, The Board may, by a two-thirds majority vote, elect to go into an executive session where non-board members shall excuse themselves from attendance. In Section 6, The Board will operate under casual discussion unless the co-chairs decide that Robert's Rules of Order must be implemented.

1. All persons should raise their hands before speaking, and the chairperson will call upon each person when it is their respective turn.

And,

THEREFORE, BE IT HEREBY FURTHER ENACTED

In Article 7 section 5 this has been added, However, LSAB can vote to sponsor a piece of legislation by a simple majority vote or endorse a piece of legislation with a 3/4th majority. And,

THEREFORE, BE IT HEREBY FURTHER ENACTED

A new added article says, Article X: Entities Subordinate to LASB

City Council Action Committee and other State and Local Policy Department entities that deal with local state and national polices and their relation with ASCSU will be overseen by LSAB. These entities have the autonomy to create their own bylaws.

THEREFORE, BE IT HEREBY FURTHER ENACTED

That a copy of this legislation be forwarded to Amy Parsons, Colorado State University President; and Dr. Blanche Hughes, Vice President for Student Affairs.
