ABSTRACT: Bill seeks to allocate remaining Board for Student Organization Funding (BSOF) funding to a seed fund controlled by Student Leadership, Involvement, & Community Education (SLiCE) for the purpose of providing seed money to new Registered Student Organizations (RSOs).

WHEREAS

BSOF has remaining funding that is estimated to be between \$10,000 and \$15,000 at the end of this academic year; and,

WHEREAS

The purpose of BSOF is to uplift and support RSOs on campus, and while some of BSOFs excess funding has been used on non-RSO related projects in the past, BSOF this year felt it should be applied to new and old RSOs in need; and,

WHEREAS

RSOs can only apply for this funding from the seed fund if they have an active Student Organization Financial Account (SOFA) account through the SLiCE office; and,

THEREFORE BE IT HEREBY ENACTED

That all remaining BSOF funding be given to the SLiCE office, and specifically the Involvement area, to manage in the ways outlined in the abstract; and,

THEREFORE BE IT HEREBY FUTHRER ENACTEDThat funding created by the seed fund be open to all RSOs; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the Director of Finance, Vice Chair of BSOF, and BSOF Advisor be the primary delegates of this seed fund; and,

THEREFORE BE IT HEREBY FUTHRER ENACTED

That RSOs seeking this money must apply for this funding for record keeping purposes on SLiCE's end; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That funding not be allocated for the following:

- 1. An RSO designed for the express purpose of benefiting University operated residential communities
- 2. An RSO recognized by the Department of Campus Recreation as a "Sport Club"
- 3. Awards, trophies, and prizes
- 4. Capital expenditures (asset or equipment) anything with more than a one-time use (please refer to CSU Financial Procedure Instructions FPI 4-1 for definitions)
 - 5. Capstones, student projects, events receiving academic credit, or scholarships
 - 6. College commencement ceremonies
 - 7. Contest entries
- 8. Contributions or expenditures, from any source, to campaigns involving the (i) nomination, retention, or election of any person to any public office; (ii) to urge electors to vote in favor of or against any statewide ballot issue, local ballot issue, referred measure or recall election
 - 9. Damage deposits
 - 10. Departmental funding
 - 11. Flower and floral arrangements
 - 12. Amusement rides or interactive games (includes but not limited to inflatables, bouncers, slides, mechanical bulls)
 - 13. Raffle tickets
 - 14. Salaries or supplemental pay (please note, honorariums cannot be made in payment to CSU employees: faculty, staff, or students)

THEREFORE BE IT HEREBY FUTHRER ENACTED

That upon acceptance, \$300 will be deposited into the RSOs SOFA account; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the Deputy Director of Finance will be the primary overseer of the funds, with assistance from SLiCE and ASCSU Advisors to track this funding; and,

THEREFORE BE IT HEREBY FUTHRER ENACTED



Once money is awarded to an RSO, it cannot seek additional funding from this slush fund; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That funding for this seed fund be allocated for the sole purpose of this fund until June 1, 2025;
