**ABSTRACT:** This bill seeks to request additional funds from Presidential Discretionary in order to provide the 2020-2021 Elections Manager with the full compensation outlined by the job description.

---

**WHEREAS:** The ASCSU Elections Manager job description provides that this position "shall receive compensation of \$3,000.00 for the fall and spring semesters beginning December 4th, 2020 and ending one week after elections,"

**WHEREAS:** Due to the change in election period from Spring 2020 to Fall 2020, the 2019-2020 Elections Manager received \$1,113.97 of the \$3000.00 allocated in the budget for this position for the 2020-2021 ASCSU fiscal year due to the continuation of this position with the temporary administration until September 30, 2020 as outlined by Joint Order II,

WHEREAS: Due to this shift in elections period consequently the elongation in pay periods for the previous Elections Manager there remains \$1,886.03 in the approved budget to compensate this position,

WHEREAS: There are two election periods in the 2020-2021 ASCSU year and the 2020 Elections Manager was ratified on November 18, 2020 under this job description and began working December 4, 2020,

WHEREAS: This is not an increase in pay solely a reallocation of funds in order to duly compensate the Elections Manager with the pay associated with the position's job description;

WHEREAS: The additional funds of the amount of \$1,113.97 will be taken out of Office of the President Discretionary in order to provide the full \$3000.00 that the Elections Manager job description provides for.

THEREFORE BE IT HEREBY ENACTED:

That \$1,113.97 be allocated from the Office of the President Discretionary in order to provide the 2020-2021 Election Manager with the full compensation of \$3000.00 as outlined by the job description.

THEREFORE BE IT HEREBY FURTHER ENACTED
