**ABSTRACT:** This bill seeks to update the 2020 ASCSU Referenda and Elections Code for the purposes of the 2021 ASCSU election cycle and future elections cycles.

**WHEREAS**

Section 806, Subsection (E) of the ASCSU Constitution states that "The ASCSU Referenda and Elections Code may only be amended by a Senate bill specifically delineating all proposed amendments"; and,

**WHEREAS**

Section 806, Subsection (F) of the ASCSU Constitution states that "The Senate may pass such a bill with a majority vote of the ASCSU Senate until six weeks prior to Spring Break"; and,

**WHEREAS**

The Senate has the duty "To initiate and enact any legislation necessary and proper"; so,

**THEREFORE BE IT HEREBY ENACTED**

That the attached copy of the ASCSU Referenda and Elections Code be adopted as the official Elections Code of ASCSU; and,

**THEREFORE BE IT HEREBY FURTHER ENACTED**

That due to the National State of Emergency the timeline in the Constitution is not accurate and Elections Manager May has the intention of updating of the Constitution to reflect said changes; and,

**THEREFORE BE IT HEREBY FURTHER ENACTED**

That the changes to the Elections Code will be implemented to the most up to date Election Code as seen in Bill 4923; and,

**THEREFORE BE IT HEREBY FURTHER ENACTED**
