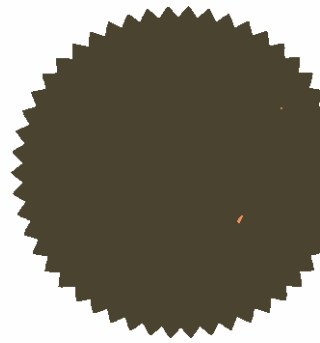

**ABSTRACT:** This bill seeks to request additional funds from the ASCSU Senate Discretionary Fund in order to provide the 2020-2021 Elections Manager with the full \$3000.00 elections budget as provided in past elections periods,

---

**WHEREAS:** The ASCSU Supreme Court budget provides for \$3000.00 per ASCSU year for the elections' budget,

**WHEREAS:** Due to the shift in election period from Spring 2020 to Fall 2020 as outlined by Joint Order II, two elections cycles will take place in the 2020-2020 ASCSU year in comparison to the single elections period that typically takes place within a single ASCSU year,

**WHEREAS:** Due to the two elections cycles taking place in the 2020-2021 ASCSU year, the elections budget currently contains \$1,322.70 out of the \$3000.00 allocated in the approved budget for the 2020-2021 fiscal year,

**WHEREAS:** There are two election periods in the 2020-2021 ASCSU year consequently requiring additional funding to provide equal funding to provide for equal resources for candidates campaigning during the second elections period,

WHEREAS: The additional funds of the amount of \$1,677.30 will be taken out of the ASCSU Senate Discretionary Fund in order to provide the full \$3000.00 that the typical elections budget consists of;

THEREFORE BE IT HEREBY ENACTED:

That \$1,677.30 be allocated from the ASCSU Senate Discretionary Fund in order to provide the 2020-2021 Election Manager with a full elections period budget consisting of \$3000.00; and,

THEREFORE BE IT HEREBY FURTHER ENACTED

That the money originally come from the ASCSU Senate Discretionary Fund, with the condition that the Office of the President and Budgetary Affairs Chair meet to discuss reallocation of funds. If a conclusion cannot be met, the money will be allocated by the ASCSU Senate Discretionary Fund; and,

THEREFORE BE IT HEREBY FURTHER ENACTED


