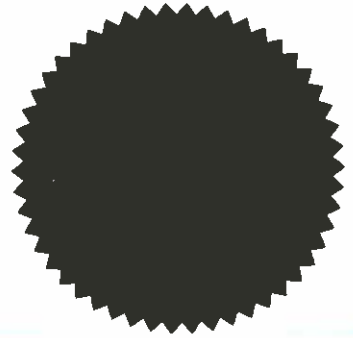

Approval of BSOF Funding for Rams Against Hunger**

**ABSTRACT:** This bill requests \$75,000 to be moved from the 2020-2021 Board for Student  
Organization Funding budget to the ASCSU General Fund to improve programs in Rams  
Against Hunger and their efforts.

**WHEREAS**

According to Article IX, Section 903 of the Constitution of the Associated Students of Colorado  
State University, "The ASCSU Board for Student Organization Funding shall have responsibility  
and authority for allocating such funds in a viewpoint neutral manner."; and,

**WHEREAS**

According to Article IX, Section 905a of the Constitution of the Associated Students of Colorado  
State University, "The Board for Student Organization Funding shall have the power to establish  
its own bylaws, rules of order, rules of procedure, and fiscal rules as the members deem  
necessary, provided that all allocations of the ASCSU Fe shall be done in a viewpoint neutral  
manner."; and,

**WHEREAS**

According to Article IX, Section 905b of the Constitution of the Associated Students of Colorado State University, "The Board for Student Organization Funding may approve allocations not to exceed \$14,000 for any one eligible organization. If a specific request exceeds \$14,000 it must be ratified by the Senate through a Bill following the Board's recommendation."; and,

**WHEREAS**

\$15,000 will be allocated to Lory Student Center Theatre rental fees, \$15,000 for a landing pad installment at the new pantry location, \$25,000 for the interior of the new pantry, \$10,000 for Rams Against Hunger Pantry events, and \$10,000 for Rams Against Hunger equipment repair and upkeep fund.; and,

**WHEREAS**

These funds will be allocated to the Senate discretionary to then be allocated to Rams Against Hunger so the funds can be fully utilized after this year and any remaining funds of the \$75,000 to go towards funding for pocket pantry materials; so,

**THEREFORE BE IT HEREBY ENACTED**

That the Fiftieth Senate of the Associated Students of Colorado State University acknowledges the need for supporting food insecurity efforts to help improve the health and success of Colorado State University's students and faculty members; and,

**THEREFORE BE IT HEREBY FURTHER ENACTED**

That \$75,000.00 of the Board for Student Organization Funding budget be allocated to the ASCSU General Fund to then be allocated to the Rams Against Hunger program and it's efforts; and,

**THEREFORE BE IT HEREBY FURTHER ENACTED**

That in the event the \$75,000 is not utilized by June 30th, 2025, the remainder of the funds will be earmarked in the ASCSU Fund Balance for Rams Against Hunger.

**THEREFORE BE IT HEREBY FURTHER ENACTED**

That a copy of this legislation be forwarded to Joyce McConnell, Colorado State University President; and Dr. Blanche Hughes, Vice President for Student Affairs; Tony Frank, Chancellor;

and Michael Buttram, Rams Against Hunger Coordinator, Gaby Brown, Director of Health; Erin Freeman, Director of Food Insecurity
