ABSTRACT: *This bill reallocates funds from ASCSU's financial advisor salary savings.*

WHEREAS

According to Article IX, Section 902 of the ASCSU Constitution: "Funds may be transferred between ASCSU departments by the President, only with the approval of Senate in the form of a Supplemental Funding Bill that shall be written and presented by the President and/or their designee"; and,

WHEREAS

Bill 5316

Under Section 902 of the ASCSU Constitution, "Multiple transfer may be presented in one Bill"; so,

WHEREAS

The salary savings for lack of a financial advisor provides an additional \$23,000 in funds that would have otherwise been spent. This provides an opportunity to utilize that money to serve students.

THEREFORE, BE IT HEREBY ENACTED

That upon passage of this bill, the following budget re-allocations will take place:

- \$5,500 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Traditions and Programming Discretionary Programs* line item to assist in funding 2024 Revival Rail Jam.
- \$5,000 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Diversity and Inclusion Discretionary Programs* line item to assist in funding the 2024 Drag Show.
- \$5,500 shall be transferred from the *Financial Advisor Salary Savings* to the *BSOF* line item.
- \$4,000 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Traditions and Programs Discretionary Programs* line item to assist in funding the end-of-year food truck event.
- \$1,500 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Health Discretionary Programs* line item to assist in funding Rams Against Hunger
- \$750 shall be transferred from the *Financial Advisor Salary Savings* to the *Graduate Affairs Discretionary Programs* line item to assist in funding the Pom-Pom suit.
- \$500 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Health Discretionary Programs* line item to assist in funding the PURIFY initiative.
- \$250 shall be transferred from the *Financial Advisor Salary Savings* to the *Department of Governmental Affairs Discretionary Programs* line item to assist in funding an inaugural legislator award.

THEREFORE, BE IT HEREBY ENACTED

\$825.00 shall be transferred from the traditions and programming budget, line item forever green shirts to line item discretionary
