ABSTRACT: This bill will allocate all of senate's excess funds into a special fund meant to fund student organizations under BSOF's jurisdiction.

WHEREAS

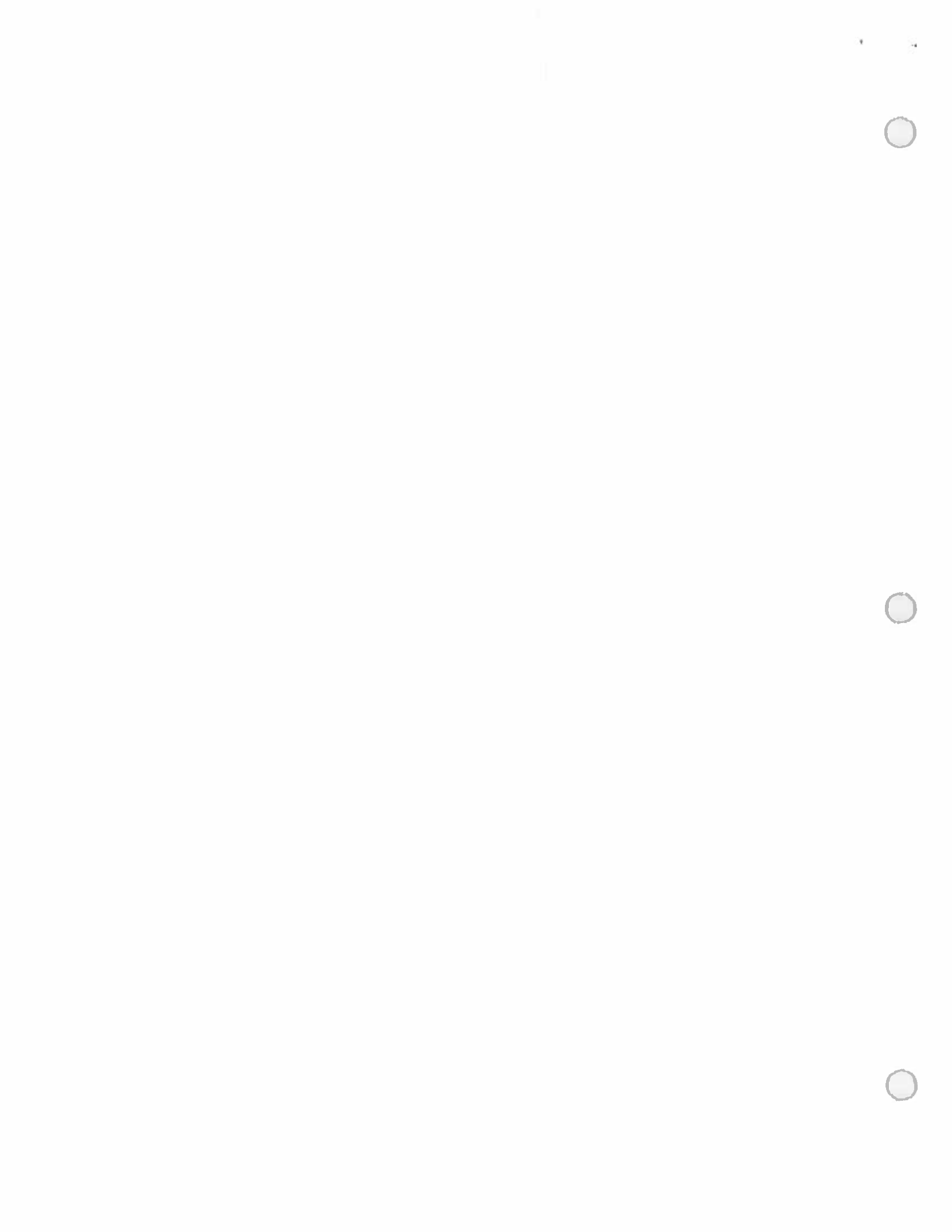
After meeting with Director Duffield and talking about Senate discretionary fund I believe it is in the best interests that a fund be created to give Senate's excess funds to BSOF for the next financial year; and,

WHEREAS

Due to COVID and other external factors, BSOF has seen a continuous decrease in its funds; and,

WHEREAS

To incentivize senate to spend money for the good of the student body or have it go to BSOF for the good of the student body.



BILL 5320

THEREFORE, BE IT HEREBY ENACTED

That all of Senate's excess money from the Senate Discretionary fund be allocated for a special fund for BSOF at the end of this fiscal year (June 30th) appropriately named the "Senate BSOF fund", instead of the fund balance; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

The Speaker Pro Tempore, the chair of the Budgetary Affairs Committee and the executive's director of finance will collaborate on giving the funds to BSOF; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

The executive branch shall prove that they have successfully given the fund to BSOF by providing documentation that BSOF has received the funds; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

If no excess money is left from senate, then the fund will stay empty; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED

If a senator wishes to create a bill to give additional money to the fund they may do so with the approval of the senate; and,

THEREFORE, BE IT HEREBY FURTHER ENACTED
