- VII. Gallery Input
 - Mitchell Meyers: Stated that there are significant uncertainties regarding politics but there have been repeated attacks on DEI. Remains committed to DEI and advocacy work, stated that diversity is our strength.
 - Fiona Miller: Stated that DEI programs have been labeled as discriminatory but, in her experience, DEI initiatives have given her opportunities to feel heard and seen and meet people from similar backgrounds. Stated that these attacks on DEI are also an attack on American values. Advocated for the university to make a statement in solidarity with DEI.

- Ellie Lutz: Stated that we must not give into fear but need to understand what is happening and be in solidarity. Stated that while we can't control what decisions are being made, we can control how we react and fight back and there is power in numbers.
 - Michael May, President of Young Democratic Socialists of America (YDSA) at CSU: Stated that support for undocumented communities and the nation's most vulnerable populations is critical. Is interested in collaborations between YDSA and ASCSU members.
 - Vladimir Lora Pardo: Stated that undocumented communities are facing immense stress and resources for undocumented students from the university are disappearing. Called for solidarity with undocumented communities but urged against people who are not undocumented speaking on undocumented students' behalf and performative activism. Stated the university needs to commit to action supporting undocumented students that extends beyond a statement.

 - BSOF Information Night is Tuesday, February 11th, 5:30 – 7:30 in the Senate Chambers
 - Vice President Braxton Dietz
 - The Student Fee Review Board (SFRB) are voting on proposals regarding student tuition increases.
 - The worst-case scenario if all if all proposals are voted “yes” on, will be a tuition increase of 2.82% or \$1,425.67.
 - Opposed to the \$1,386.59 students paid last year.
 - Reviewing these proposals on a weekly proposal and voting.
 - More updates to come.
 - President Nick DeSalvo
 - President DeSalvo and Governmental Affairs will be meeting with the Joint Budget Committee to advocate for funding higher education.
 - Will be absent next week to attend the Board of Governor’s Meeting.

XII. Legislative Reports

- Officer Reports
 - Speaker Taylor
 - Echoes President DeSalvo's message.

- Campaigned for Speaker of the Senate on a platform for student advocacy where all students are heard. Remains equally committed to those principles today and will work with ASCSU leaders and members to ensure the success of the organization and greater student body.
- The Budgetary Affairs Committee Chair is vacant. Next week there will be an election to fill the position, if you are interested, reach out to Speaker Taylor.
- Decorum is outlined in the Senate Bylaws for a reason and motions to suspend these rules will not be entertained.
- Parliamentarian Kamberg
 - Discussed that not everything signed by the president is enforceable and fear is a tactic to get people to turn on each other. Condemned attacks on DEI and attacks on undocumented communities. Stated that we are stronger in community and ASCSU will not back down.
 - Encouraged switching from CSU emails to personal emails to discuss advocacy work since university emails may be monitored.
 - There are red cards in different languages on a table of the ASCSU lobby.
- Speaker Pro-Tempore Reese

- Ran for Speaker Pro-Tempore to uplift the autonomies of senators and magistrates to utilize the full power of their positions.
Encouraged people to share their thoughts or questions regarding how the new presidential administration will affect ASCSU.
- Knowledge and outreach are critical components to empowering ASCSU to represent the student body. Implored everyone in ASCSU to use resources and gain more knowledge.
 - Including the Social Justice Library in the ASCSU Office.

- Bill #5408 - Increased funding to Rams Against Hunger Pocket Pantries

- Abstract: This bill seeks to continue ASCSU’s legacy of supporting the Ram’s Against Hunger Pocket Pantry Program, allocating \$54,000 from the ASCSU General Discretionary Fund to the Rams Against Hunger Pocket Pantry Fund, bringing the total budget from the previous \$12,000 to now \$18,000 for each academic year, during the next three-year cycle, (\$9,000 per semester, \$18,000 per year, \$54,000 per three-year cycle) beginning June 2025.
 - This Bill continues the precedent of ASCSU funding the pocket pantries which need to be renewed every three years.
 - The current budget does not fit with the state of food prices, housing prices, inflation, etc. and there is a rising need from students/CSU Community so an increase in funding is needed.
 - The funding would be spread across 8 pocket pantries so it would be a modest but still impactful budget increase.
 - Bill will be sent to DEI Committee, Internal Affairs Committee, and University Affairs Committee.
 - Because of a vacancy for the Budgetary Affairs Committee Chair, the process for this Bill will likely take a bit longer to leave committees.
 - Resolution #5407 - Asking Colorado State University Administrator for More Accountability and Transparency

- Abstract: “we ask Colorado state university administration and leadership to provide more transparency on their decision making and the processes that happen on campus. As well as take more accountability by providing more tangible and actionable means of improving support on campus and addressing the student body during times of distress”
- Resolution will be sent to DEI Committee, Internal Affairs Committee, and University Affairs Committee.
